# Cystic Fibrosis beatable, but we need your help

- Cystic fibrosis is a life-shortening genetic condition that slowly destroys the lungs and digestive system.
- Over 10,000 people in the UK live with cystic fibrosis
- 5 babies are born each week with cystic fibrosis
- 2 people die every week due to cystic fibrosis
- 1 in 25 of us carries the faulty cystic fibrosis gene, most without knowing it
- The Cystic Fibrosis Trust is the only UK-wide charity making a daily difference to the lives of people with cystic fibrosis, and those who care for them.

## Gift Aid Declaration

**Gift Aid:** The Cystic Fibrosis Trust can claim an extra 25p for every £1 you donate if you are a UK taxpayer and you tick the box on this sponsorship form. By ticking the box you are confirming you would like the Cystic Fibrosis Trust to reclaim tax on the donation detailed, given on the date shown.

To qualify for Gift Aid you must pay an amount of income tax and/or capital gains tax (but not including council tax or VAT) for each year (6 April to 5 April) that is at least equal to the amount that all charities or community amateur sports clubs that you donate to will reclaim on all your gifts for that tax year.

You must also understand that if you pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all your donations in that tax year it is your responsibility to pay any difference.

**Note to Participant:** While anyone can sponsor you, the charity may not be able to claim Gift Aid from all your sponsors who tick the Gift Aid box. HMRC rules state that Gift Aid can not be claimed for a person connected to the participant. A connected person includes the participant's husband, wife, civil partner, son, daughter, parent, grandparent, grandchild and in-laws.
